full training through the U.C.L.A. Implant Center during his three year residency training programs. He has lectured extensively on several aspects of prosthodontics and implant dentistry, both nationally and internationally. Dr. Faulkner is the director of The Ohio Center for Osseointegration, a state of the art continuing education facility for clinicians, technicians, and auxiliaries. He has a faculty appointment as a Lecturer for the Department of Removable Prosthodontics at U.C.L.A. and is a volunteer Assistant Professor of Surgery at the University of Cincinnati, where he conducts the treatment planning seminars for implant dentistry for the Oral and Maxillofacial Surgery residency program. Dr. Faulkner resides in Cincinnati, Ohio where he maintains a private practice limited to fixed and removable prosthodontics, maxillofacial prosthetics, and implant prosthodontics.

As implants become the standard of care treatment option for edentulism, incorporating implant therapy into your dental practice can help increase both profitability and patient satisfaction. There are, however, several considerations for achieving optimal long-term results. This course will provide a comprehensive review of the systems, communication, clinical considerations and technical knowledge needed to successfully grow the implant portion of your practice.

This presentation will review current information regarding treatment planning for dental implants including patient selection, coordinating treatment with the implant surgeon, and communication with the laboratory. Contraindications for dental implants will also be discussed.

thodontics at the University of Washington in Seattle. He also maintains a private orthodontic practice in Tacoma, Washington. He has published 21 book chapters, 84 scientific articles, and 48 review articles. Doctor Kokich is Editor of Case Reports for the American Journal of Orthodontics and Dentofacial Orthopedics, Associate Editor of



The Angle Orthodontist, Associate Editor of Practical Reviews in Orthodontics, and serves on the Advisory Board of the Journal of Esthetic Dentistry, and the Editorial Boards of the Journal of the American Dental Association, Seminars in Orthodontics, Clinical Orthodontics and Research, Dental Traumatology, and The Australian Orthodontic Journal. He has served as President of both the American Academy of Esthetic Dentistry and the American Board of Orthodontics.

Many patients that present to the general dentist have multiple problems that can negatively affect the occlusal and esthetic outcome of dental treatment. Therefore, a team is often necessary to correct these problems. In order to communicate properly, the team must discuss these cases in an interdisciplinary manner. This process involves establishing a problem list, creating treatment objectives, identifying treatment alternatives, and then deciding which of the treatment alternatives best achieves the needs of each patient. These steps are followed by establishing the vision for treatment as well as the correct sequence of multidisciplinary dental care. Each patient's periodontal health must also be assessed in order to overcome any underlying periodontal problems that would negatively affect the treatment outcome. Managing these steps in the correct order will insure successful treatment. Skipping any of these critical steps can result in an unhappy patient and a less than ideal result. This presentation will provide the audience with a series of interdisciplinary guidelines for managing the patient with multidisciplinary dental problems.
