How to Reduce High Bites and Open/Tight Contacts

Too many crowns/bridges look perfect on the model only to fall drastically short of expectations at the seating appointment. The necessary time-consuming adjustments to the occlusion and/or contacts can leave you and your patient feeling frustrated.

Finding a laboratory that can deliver a completed case requiring little to no adjustment is the biggest challenge a dentist faces when prescribing a crown or bridge.
