Dr. Johnson received his DDS degree from NYU in 2008 and Certificate in Endodontics from Case Western School of Dental Medicine in 2011. He is a Diplomate of the American Board of Endodontics, and head endodontic attending for the GPR program at Interfaith Medical Center Hospital in Brooklyn. He has given numerous presentations on endodontics for many local and national meetings. Dr. Johnson practices full-time in his private office in midtown Manhattan.

This presentation will highlight real-life techniques and strategies touching on endodontic case management, from administering local anesthetic to controlling intra operative pain. The goals of this lecture include: 1) enhance understanding of managing root canal cases from start to finish; 2) accurately diagnose a patient's chief complaint of pain; 3) understand canal morphology and understand successful endodontic treatment; 4) gain better understanding of how to eliminate intracanal bacteria; and 5) understand why some endodontic cases fail to heal despite seemingly ideal endodontic treatment.

ment and be able to prove your diagnosis and reasoning for treatment planning this code. Delta Dental has purchased a dental analytics company. Each dentist is being monitored for their utilization of various procedure codes. If you receive any correspondence from Delta with reference to this topic, be certain to contact Dr. Joan Monaco at the NJDA. This means you will be getting more audits in the future. Auditors hired through Delta get compensated based on a percentage of the settlement. REGARDING ALL INSURANCE AND GENERAL DOCUMENTATION: It is of the utmost importance that every time you make an entry into your patient chart there must be a diagnosis and treatment plan. You must document your thinking and rationale for all procedures that you perform to justify that the procedure is medically/dentally necessary and that you are not just doing random work without need. For example: do not write #2- occlusal composite but rather Diagnosis: caries on the occlusal surface of #2; Treatment Plan: excavate caries and restore tooth with composite. Dr. Keith Libou from Delta Dental will be attending our next council meeting. We are asking all members to submit universal questions to ask Dr. Libou. Your names will not be needed but we want to take this opportunity to address the membership's questions and concerns directly with the Director of Delta. We need questions in writing by the end of October please. You can email Joan or myself at dr.tauk@verizon.net. I will forward all questions to Joan directly. Members will need to purchase the new edition of the CDT codes for 2019. There are 15 new codes, 5 revised codes, and 12 deleted codes. The changes are significant enough to warrant purchasing a new book.
